Minutes of the New York State Board of Elections March 14, 2023

A meeting of the New York State Board of Commissioners was held virtually via Webex and was called to order at approximately 12:22 p.m. The meeting was chaired by Commissioner Peter Kosinski. - · VOTE on Resolution 23-15 to adopt amendments to 9 NYCRR Subtitle V Parts 6200 by amending Section 6200.1 related to the filing of statement of campaign receipts and expenditures. The motion was approved unanimously (Commissioners Kellner, Kosinski, Spano and Casale voting in the affirmative; 4 Yes and 0 No).

APPROVAL OF KNOWINK ELECTRONIC POLL BOOK SYSTEM UPGRADES

WHEREAS, Part XX of Chapter 55 of the New York Laws of 2019 authorizes the use of Electronic Poll Book Systems (EPBS) in New York State during elections; and

WHEREAS, said chapter law provides that the State Board of Elections "shall promulgate minimum security standards" for EPBSs being used in New York State; and

WHEREAS, said chapter law provides that the State Board shall "promulgate a list of devices that are approved for use" as EPBSs during elections; and

WHEREAS, KNOWiNK has submitted system modifications to be considered for approval as an EPBS configuration for use in New York State; and

WHEREAS, the Election Operations Unit is tasked with evaluating the systems to ensure they meet security standards and other relevant standards; and

WHEREAS, the Election Operations Unit has conducted an evaluation of said systems, and has provided summary reports for the consideration of the Board; and

WHEREAS, vulnerability scanning was performed on the systems submitted, to the extent practicable, by staff of the State Board's Secure Election Center (SEC) in conjunction with Elections Operations staff, and reports of their findings have been provided for the consideration of the Board; and

WHEREAS, having considered the reports and the results of evaluation conducted by the Election Operations Unit, we do hereby recommend the approval of system configurations submitted by the following vendors for use;

o Pollpad v. 3.4.0 / iPadOS v. 16.3.1

NOW THEREFORE BE IT RESOLVED that the Commissioners of the New York State Board of Elections, at their meeting convened on March 14, 2023, do hereby approve the EPBS aforementioned configurations submitted by the vendor above. Such approval is based on the specific EPBS hardware and software submitted by the vendor and reviewed by the State Board of Elections. Should the vendor make, or plan to make, any modifications or alterations to the EPBS configuration approved, such modifications or alterations shall be reviewed by the State Board of Elections for approval, consistent with all change management procedures and the use of such systems shall comply with all related State Board procedures and requirements.

BE IT FURTHER RESOLVED that counties utilizing the vendor system described above may opt to either upgrade their equipment to one of the configurations approved in this resolution for use at the June 27, 2023 Primary Election or continue to use the most recently approved configuration for each system. Any county opting for the latter option must complete the upgrade of their equipment to the newly certified configuration before being used in a subsequent election.

Resolution of the State Board of Elections Approving Individuals to Serve as Hearing Officers in Conjunction with Election Law § 3-104 (5)(a)

WHEREAS, the Election Law was modified pursuant to Chapter 55 of the Laws of 2014 to include a hearing process for certain violations of the Election Law that do not otherwise warrant a criminal prosecution; and

WHEREAS, said hearing process, as established in Election Law § 3-104(5)(a), calls for the State Board of Elections to establish a list of prospective Hearing Officers, each of whom shall have been approved by a majority vote of the Board; and

WHEREAS, Naomi Abramowitz, Richard Kass, Nikki Moreschi, and La'Teea Goings were previously appointed by the Board to serve as Hearing Officers on April 22, 2021, for a term that will expire on April 30, 2023; and

WHEREAS, the Board wishes to reappoint such individuals to serve as Hearing Officers for another term;

NOW THEREFORE BE IT RESOLVED that the New York State Board of Elections approves Naomi Abramowitz, Richard Kass, Nikki Moreschi, and La'Teea Goings to serve as Hearing Officers; and

NOW THEREFORE BE IT FURTHER RESOLVED that this resolution expires April 30, 2025.

WHEREAS, on December 23, 2022 and March 3, 2023, the Governor signed into law Chapter 744 of the Laws of 2022 and Chapter 77 of the Laws of 2023, which amended provisions of the Election Law, related to objections to certain ballot access documents and notification by electronic means; and

WHEREAS, it is necessary to amend Section 6204.1 and 6215.8 of Title 9 of the NYCRR in order to implement the provisions of these chapters and to provide uniformity to objections to certain ballot access documents and revisions to the sample cover sheet; and

WHEREAS, the effective date of Chapter 744 of the Laws of 2022 and Chapter 77 of the Laws of 2023 is March 23, 2023, and certain regulatory and procedural changes will need to be effectuated in time for the upcoming ballot access document filing and objection periods; and

WHEREAS, time is of the essence, as it would be impossible to adopt these regulations in time for the above cited filing and objection periods if these amendments were to be adopted in the normal course of business; and

WHEREAS, based upon the foregoing, it is necessary for the general welfare of the public that Sections 6204.1 and 6215.8 of Title 9 of the NYCRR be added on an Emergency Basis, in accordance with SAPA § 202;

NOW THEREFORE BE IT RESOLVED: that the New York State Board of Elections does hereby adopt the amended Sections 6204.1 and 6215.8 of the NYCRR and

the Office of Counsel is hereby authorized and directed to take steps necessary pursuant to SAPA § 202 to effectuate this ninety-day emergency adoption of the amendment to 9 NYCRR Subtitle V Sections 6204.1 and 6215.8; and

BE IT FURTHER RESOLVED: that the Office of Counsel is hereby authorized and directed to take steps necessary pursuant to SAPA § 202 to provide for the publication of proposed rulemaking related to the permanent amendment to 9 NYCRR Subtitle V Sections 6204.1 and 6215.8 and to provide notice of the public comment period of sixty days thereafter.

WHEREAS, it is necessary to add Section 6215.10 of Title 9 of the NYCRR in order to implement the provisions of the statute and to provide for the designation of party positions determined by gender; and

WHEREAS, the effective date of Chapter 231 of the Laws of 2022 was June 26, 2022, and certain regulatory and procedural changes will need to be effectuated by the petitioning period; and

WHEREAS, time is of the essence, as it would be impossible to adopt these regulations in time for the above cited petitioning period if these amendments were to be adopted in the normal course of business; and

WHEREAS, based upon the foregoing, it is necessary for the general welfare of the public that Section 6215.10 of Title 9 of the NYCRR be added on an Emergency Basis, in accordance with SAPA § 202;

NOW THEREFORE BE IT RESOLVED: that the New York State Board of Elections does hereby adopt the amended Section 6215.10 of the NYCRR and the Office of Counsel is hereby authorized and directed to take steps necessary pursuant to SAPA § 202 to effectuate this ninety-day emergency adoption of the amendment to 9 NYCRR Subtitle V Section 6215.10; and

BE IT FURTHER RESOLVED: that the Office of Counsel is hereby authorized and directed to take steps necessary pursuant to SAPA § 202 to provide for the publication of proposed rulemaking related to the permanent amendment to 9 NYCRR Subtitle V Section 6215.10 and to provide notice of the public comment period of sixty days thereafter.

WHEREAS, on October 28, 2019, November 8, 2019, and April 17, 2020, the Governor signed into law Chapters 416 and 465 of the Laws of 2019 and Chapter 34 of the Laws of 2020, which amended provisions of the Election Law, related to the filing of statements of campaign receipts and expenditures; and

WHEREAS, Election Law § 3-102(1) provides the Board "shall have the power and duty to ... promulgate rules and regulations relating to ... campaign financing practices ... consistent with the provisions of law"; and

WHEREAS, it is necessary to amend Section 6200.1 of Title 9 of the NYCRR in order to implement the provisions of the statutes and to provide for the place of filing of statements of campaign receipts and expenditures;

NOW THEREFORE BE IT RESOLVED: that the office of counsel is hereby authorized and directed to take steps necessary pursuant to SAPA § 202 to provide for the publication of the proposed rulemaking related to amending Section 6200.1 of 9 NYCRR Subtitle V and to provide notice of the public comment period of sixty days thereafter.
