Commissioner Kellner: Good afternoon, everyone, I'll call this meeting to order. All four Commissioners are present, and the sole item on the agenda is the review of the staff report on petition objections. Who wants to present the report? I believe the most recent report was sent to us about 10 minutes ago. It had one minor revision, is that correct?

Todd Valentine: Right, it should be dated today's date at the bottom quarter, if you're looking at the version.

Brendan Lovullo: This is the list of all the Senate and Congressional both objections, the petitions, and then any of the acceptance authorizations, that is either through not filing something, or objections that the staff recommends to you to invalidate or validate as the document says.

Commissioner Kellner: Okay, so are there any comments? And is there a motion to approve the report?

Commissioner Casale: So moved.

Commissioner Spano: Second.

Commissioner Kellner: Those in favor say aye.

Commissioner Spano: Aye.

Commissioner Casale: Aye.

Commissioner Kellner: Aye.

Commissioner Kosinski: Aye.

Commissioner Kellner: Alright it's unanimously approved, and I believe that's the only business we have today. Does anybody have anything they want to say?

Commissioner Kosinski: No, I have no more business.

Commissioner Kellner: So on a motion to adjourn, those in favor say aye.

Commissioner Spano: Aye.

Commissioner Casale: Aye.

Commissioner Kellner: Aye.

Commissioner Kosinski: Aye.

Commissioner Kellner: Alright, we stand adjourned.

Commissioner Kosinski: I'm sorry before we end, do we have a next meeting scheduled?

Commissioner Spano: You know I didn't get this meeting till 2 days ago, but it was like we were notified, and I didn't remember being notified.

Commissioner Kosinski: Well, I knew about this, I knew it came up because of the court action and because of all the changing of the calendar for these particular offices, so I guess I knew about it a few days ago for that reason. But I didn't know if we had another meeting scheduled. I know the calendar is a little out of whack because of all the changes that were made, so I didn't know if we had another meeting that we'd scheduled for the next meeting.

Commissioner Spano: I thought we left it in abeyance.

Commissioner Kosinski: Yeah, I think maybe we did. I didn't know if we had any more clarity on that now.

Commissioner Spano: Well I got a list, I'm sure we all did a list of possible dates that we should keep ourselves free. We all got that right?

Kristen Zebrowski Stavisky: Yes, and then you should have gotten from Ryan several days ago an invitation for today. And I think we're just going to go over that list, I think we have to shift one date, so we will be back in touch with all the dates for you.

Commissioner Spano: Kristen, is there a time on that list, for each one of those dates?

Todd Valentine: We usually assume 12:00 p.m. unless otherwise specified.

Commissioner Spano: Okay, just want to know.

Todd Valentine: Yeah, we assume that. I think the next date we were looking at was based on the filing period for the designated districts that are coming up in June 8 to the 10th that we would need to meet somewhere around Monday June 27th in order for us in time to certify by the 29th of June would be our next meeting.

Commissioner Kosinski: Okay, so that's what you're looking at, end of June okay. Thank you, I have nothing else.
