# Resolution to Amend 9 NYCRR Subtitle V Part 6217.7 Related to Transfers of Voter Registration and Enrollment to Reflect Statutory Changes As Required By Chapter 3 of the Laws of 2019 Pursuant to State Administrative Procedures Act (SAPA) § 202

WHEREAS, on February 27, 2019, this body determined that it was necessary to amend Subtitle V of Title 9 of the Official Compilation of Codes, Rules and Regulations of the State of New York Part 6217.7 on an emergency basis, related to transfers of voter registration and enrollment to reflect statutory changes as required by Chapter 3 of the Laws of 2019; and

WHEREAS, this body simultaneously authorized the Office of Counsel to take steps necessary pursuant to SAPA § 202 to provide for the publication of the proposed rulemaking related to this same proposal; and

**WHEREAS**, on March 18, 2019, the office of counsel took action necessary for the publication of Emergency/Proposed Rule Making related to the proposal, which was published on April 3, 2019 in the New York State Register under ID SBE-14-19-00006-EP; and

**WHEREAS**, one public comment has been received related to the Emergency/Proposed Rule Making during the time provided by law for comment; and

WHEREAS, no further amendments are recommended to the proposal;

**NOW THEREFORE BE IT RESOLVED** that the amendments of Part 6217.7, attached hereto, is hereby adopted and the Office of Counsel is authorized to file a Notice of Adoption indicating that such Part shall be effective upon publication in the New York State Register, and that further authority is granted to the Office of Counsel to file such other documents as may be required for the publication of such Notice of Adoption in the New York State Register and to effectuate the amendments to Part 6217.7 of Title 9 of the NYCRR.

## Resolution to Amend 9 NYCRR Subtitle V Part 6217 Related to Pre-Registration of Persons Who Are At Least 16-Years-Old, Pursuant to State Administrative Procedures Act (SAPA) § 202

WHEREAS, by the unanimous vote of the Commissioners present at a meeting held in Albany, New York, on February 27, 2019, the New York State Board of Elections, pursuant to the authority of Election Law §§ 3-102 (1); 3-102 (17) and Chapter 2 of the Laws of 2019, resolved to authorize Counsel's Office to file Proposed Rule Making with the New York Department of State that would provide that persons who are at least 16-years-old, and are otherwise qualified to register to vote, to pre-register to vote; and

**WHEREAS,** said proposal with accompanying submissions as required by law were duly filed with the Department of State on March 19, 2019 and thereafter duly published in the New York State Register on April 3, 2019 (ID Number SBE-14-19-00005-P); and

**WHEREAS,** one public comment has been received related to the Proposed Rule Making during the time provided by law for comment; and

WHEREAS, no further amendments are recommended to the proposal;

NOW THEREFORE BE IT RESOLVED that the amendments of Part 6217, attached hereto, is hereby adopted and the Office of Counsel is authorized to file a Notice of Adoption indicating that such Part shall be effective upon publication in the New York State Register, and that further authority is granted to the Office of Counsel to file such other documents as may be required for the publication of such Notice of Adoption in the New York State Register and to effectuate the amendments to Part 6217 of Title 9 of the NYCRR.

## RESOLUTION AUTHORIZING THE EXPENDITURE OF A SUM NOT TO EXCEED \$50,000 FROM THE STATE OPERATIONS HAVA FUND FOR PAYMENT OF THE COSTS ASSOCIATED WITH THE MICROSOFT PREMIER SUPPORT AGREEMENT

## New York State Board of Elections APPROVED RESOLUTION – JUNE 6, 2019

### APPROVAL OF ELECTRONIC POLL BOOK SYSTEMS

**WHEREAS**, Part XX of Chapter 55 of the New York Laws of 2019 authorizes the use of Electronic Poll Book Systems (EPBS) in New York State during elections; and

**WHEREAS**, said chapter law provides that the State Board of Elections "shall promulgate minimum security standards" for EPBSs being used in New York State; and

**WHEREAS**, said chapter law provides that the State Board shall "promulgate a list of devices that are approved for use" as EPBSs during elections; and

**WHEREAS**, multiple vendors have submitted systems to be considered as an approved EPBS in New York State; and

**WHEREAS**, the Election Operations Unit is tasked with evaluating the devices to ensure they meet security standards and other relevant standards; and

**WHEREAS**, the Election Operations Unit has conducted evaluations of said systems, and has provided summary reports, for the consideration of the Board; and

**WHEREAS**, vulnerability scanning was performed on the systems submitted, to the extent practicable, by the New York State Division of Homeland Security and Emergency Services (DHSES) and the New York State Technology Enterprise Corporation (NYSTEC), and reports of their findings have been provided, for the consideration of the Board; and

**WHEREAS**, having considered the reports and the results of evaluation conducted by the Election Operations Unit, we do hereby recommend the approval of system configurations submitted by the following vendors for use;

- KNOWiNK
- Robis Elections, Inc.
- Tenex Software Solutions, Inc.

**NOW THEREFORE BE IT RESOLVED** that the Commissioners of the New York State Board of Elections, at their meeting convened on June 6, 2019, do hereby approve the EPBS submitted by the vendors above. Such approval is based on the specific EPBS hardware and software submitted by each vendor and reviewed by the State Board of Elections. Should the vendor make, or plan to make, any modifications or alterations to the EPBS configuration approved, such modifications or alterations shall be reviewed by the State

Board of Elections for approval, consistent with all change management procedures and the use of such systems shall comply with all related State Board procedures and requirements.
