Peter Kosinski: I'll open up the meeting of the State Board of Elections here on August 22, 2018 via video conferencing. My name is Peter Kosinski. I am joined by Commissioner Kellner and Commissioner Peterson on video and joining us through audio is Commissioner Spano. We also have staff joining us from the office. Maybe staff can just indicate who's there in the room.

One is regarding the Congressional District 21 The United, I'm sorry, the Unites Party nominating Tedra Cobb. The second is CD 19, Friends of Diane Neal Party. Purporting to nominate Diane Neal. The third is CD 19, Hudson Valley Happiness Party to nominate Dal LaMagna. And the CD 12, Rent Too Damn High Party nominate Eliot Raben. Is there anyone who wishes to speak on any of those petitions?

The first petition, the 12 CD the Rent Too Damn High Party was not timely filed and filed at the wrong board. But following a hearing on each one of those petitions, the staff has recommended that all three, based on the objections that were made, below the necessary number of ballot signatures and they are recommending that the petitions be invalidated.
