#### Minutes of the New York State Board of Elections December 15, 2015

The meeting of the Board of Canvassers of the New York State Board of Elections was convened at the offices of the New York State Board of Elections, 40 North Pearl Street, Albany, New York in the 5<sup>th</sup> Floor Conference Room and was called to order at 12:05 p.m. The meeting was chaired by Commissioner Peter Kosinski. Commissioners present were Douglas Kellner, Andrew Spano and Gregory Peterson.

The Board of Canvassers considered a motion to certify the General Election results for the November 3, 2015 Election. The motion was approved unanimously (Commissioners Kellner, Kosinski, Spano and Peterson voting in the affirmative; 4 Yes and 0 No).

The meeting of the Commissioners of the New York State Board of Elections held at the offices of the New York State Board of Elections, 40 North Pearl Street, Albany, New York in the 5<sup>th</sup> Floor Conference Room was called to order at 12:25 p.m. The meeting was chaired by Commissioner Peter Kosinski. Commissioners present were Douglas Kellner, Andrew Spano and Gregory Peterson. # Minutes of November 17, 2015 – Minutes were accepted (Commissioners Kellner, Kosinski, Spano and Peterson voting in the affirmative; 4 Yes and 0 No). Executive Minutes were held over until next board meeting.

## Unit Updates:

**Executive** – Robert Brehm and Todd Valentine reported on several issues including:

- Bob Brehm, Brian Quail, Commissioner's Kellner and Spano participated in an Assembly Hearing in New York City and Albany on improvements to the voting process.
- The Election Commissioner's Association Winter conference is scheduled for next month here in Albany.
- Chapter 515 was signed into law which is the use of automated tools and performing Post Election Audits.

Legal – Kim Galvin reported on activities related to the Counsel/Compliance Unit including:

- Working on the Legislative Package
- Meeting to discuss de Minimis list of deficiencies for compliance reviews.
- Hearing Officer Process is fully functional
- The oral argument on the LLC case is December 16<sup>th</sup>.
- Tom Connolly and Cheryl Couser participated in the Civic New York Event on November 20<sup>th</sup>.

Election Operations – Anna Svizzero reported that the Election Operations unit is working on several ongoing issues including:

- Working on two other upgrades.
- Year-end reporting documents have been sent to the County Boards and hope to receive them back by end of the year.
- Working with the county boards to get their contracts in order for shoebox reimbursements.

**PIO/NVRA** – John Conklin and Tom Connolly reported that the PIO/NVRA unit is working on several issues.

- Website has been updated with voter registration deadlines for the 2016 elections.
- Participated in the NYSVoter Refresh and CAPAS/FIDAS Project meetings.
- Suffolk County has a Special Election on January 26<sup>th</sup>
- Tom Connolly attended two conferences in Nashville. Receiving requests from other states for the crosscheck system with regard to possible duplicate voters.

ITU – Mark Goldheaber reported on projects IT is working on:

- Working on the VPN (Virtual Private Network) System upgrade.
- Will make sure that mobile access is addressed in the CAPAS/FIDAS and NYSVoter upgrades.

**Enforcement** – Risa Sugarman reported on the Enforcement Unit:

- Preparing to send out failure to file letters to the local filers.
- Discussion about creating a committee with Compliance and Enforcement staff to look into committees that are on hold.
- Looking into a Data Analytics Program.

- The Independent Expenditure Regulations are still being worked on.

- VOTE on Resolution certify of Dominion Upgrade to ImageCast Central Count (ICC) Voting System. The motion was approved unanimously Commissioners Kellner, Kosinski, Spano and Peterson voting in the affirmative; 4 Yes and 0 No.)
- The next board meetings is scheduled for January 11th.
