A meeting of the New York State Board of Commissioners was held at the office of the New York State Board of Elections, 40 North Pearl Street, Albany, New York in the 5<sup>th</sup> Floor conference room and was called to order at approximately 12:57 p.m. The meeting was chaired by Commissioner Peter Kosinski, who attended virtually. #### I. Certification of Election Results from November 8, 2022 Election

There was a motion to direct the State Board's Counsels to follow the process for promulgating a regulation to address this issue. The motion was approved unanimously (Commissioners Kellner, Kosinski, Spano and Casale voting in the affirmative; 4 Yes and 0 No).
