Delegate Selection Plan

Pursuant to Chapter 474 of the Laws of 2023, a state committee providing for the selection of delegates and alternate delegates to a national party convention or conference must select either the §3 plan or the §4 plan contained in the act.

- 10/31/23 Last day for a party to select their delegate selection method. §2 Chapter 474 Laws of 2023
- 11/14/23 Last day for other political parties to choose Republican plan. §2-122-b (1)

Republican Delegate Selection Plan Filing Dates

- 12/12/23 Deadline for party to certify number of delegates. §2-122-b (2)
- 12/12/23 - 01/30/24* Dates for nationally known candidates or matching fund candidates to file certificate with SBOE requesting to appear on ballot. §2-122-b (3)(a-b)
- 02/06/24 Last day for SBOE to certify nationally known or matching fund candidates. §2-122-b (3)(b)
- 02/06/24* Last day for presidential candidate to file certificate to have their name removed from the primary ballot. §2-122-b (3)(d)
- 03/26/24 Last day for presidential candidate to file certificate deeming any vote for such candidate to be a void vote. §2-122-b (3)(d)

Democratic Delegate Selection Plan Filing Dates

- 01/22/24 Last day for CBOEs to notify SBOE of candidates which filed at CBOE. §2-122-a (6)(h)
- 01/23/24 Last day for party committee to file certificate of candidacies for delegate and alternate delegate candidates. §2-122-a (7)(a-b)
- 02/06/24 Last day for candidates to decline designations. §2-122-a (2)

- 02/08/24 Last day for SBOE to notify party committee of candidates who will appear on ballot. §2-122-a (7)(d)
- 02/09/24 Last day for CBOEs to notify party committee of candidates who will appear on ballot. §2-122-a (7)(d)

Absentee Voting for Presidential Primary Election

- 03/23/24* Last day application for ballot must be received by BOE. §8-400 (2)(c)
- 04/01/24* Last day to apply in person for ballot. §8-400 (2)(c)
- 04/02/24 Last day to postmark ballot **and** the postmarked ballot envelope must be received by the BOEs by April 9, 2024. §8-412 (1)
- 04/02/24* Last day to deliver ballot in person to CBOE. §8-412 (1)

Military/Special Federal Voters for Presidential Primary Election

- 02/16/24 Date for CBOEs to transmit Military/Special Federal ballots. §§10-108 (1) & 11-204
- 03/23/24* Last day for a BOE to receive application for ballot if not previously registered. §§10-106 (5) & 11-202 (1)(a)
- 03/26/24* Last day for a BOE to receive application if previously registered. §§10-106 (5) & 11-202(1)(b)
- 04/01/24* Last day to apply personally if previously registered. §10-106 (5)
- 04/02/24 Last day to postmark ballot and date it must be received by the CBOEs is April 9, 2024. §§10-114(1) & 11-212

Early Voting for Presidential Primary Election

- 02/17/24 Last day to designate early voting polling places, and their hours of operation for the Presidential Primary Election. §8-600 (4)(e)
- 03/23/24 - 03/30/24 Days of Early Voting for the Presidential Primary Election §8-600 (1)(b)

Presidential Electors

- 9/06/24 Last day for party committees to file certificate of party nomination of candidates for elector of President and Vice-President of the United States. §6-158 (6)(c)

This political calendar is a ready reference to the significant dates pertaining to elections to be held in this State. For complete information consult the State's Election Law and Regulations and any relevant court orders.

All dates are based on statutory provisions in effect on the date of publication and may be subject to change. Final confirmation should be obtained from your county board of elections or the State Board.

Filing Requirements Generally: Except where otherwise required to be "received by" a date certain (such *received by* dates are designated with an asterisk "**"), all certificates and petitions of designation or nomination, certificates of acceptance or declination of such designations or nominations, certificates of authorization for such designations or nominations, certificates of disqualification, certificates of substitution for such designations or nominations and objections and specifications of objections to such certificates and petitions required to be filed with the State Board of Elections or a board of elections outside of the city of New York shall be deemed timely filed and accepted for filing if sent by mail or overnight delivery service, in an envelope postmarked or showing receipt by the overnight delivery service prior to midnight of the last day of filing, and received no later than two business days after the last day to file such certificates, petitions, objections or specifications shall be a fatal defect per NYS Election Law 1-106.

Within NYC Filing Deadlines: All such certificates, petitions and specifications of objections required to be filed with the board of elections of the city of New York must be actually received on or before the last day to file. The New York City Board of Elections is open for the receipt of such petitions, certificates and objections until midnight on the last day to file.
