** **24-Hour Notice** - During these time periods, any contribution or loan which exceeds \$1,000 must be reported within 24 hours of receipt via fax or via the EFS Web Application <https://elections.ny.gov/electronic-filing-system-efs-web-application> This same contribution or loan must also be reported in the associated Post Election report.

*** **Additional Independent Expenditure Reporting Requirements** - Independent Expenditure Committees have additional 24-hour notice and Weekly Notice requirements. Please refer to EL 14-107(4)(a) & (b).
